#### REPORT OF RECEIVER'S ACTIVITIES

### **April 1, 2022 through June 30, 2022**

This report covers the activities of the Receiver<sup>1</sup> for the second quarterly period of 2022. The Receiver was appointed on October 20, 2021 (the "Appointment") [ECF No. 284].

Section XI of the Order Appointing Receiver [ECF No. 153] (the "Receiver Order") directs the Receiver to file a report and accounting of the Receivership Estate on a quarterly basis. This is the third quarterly report to the Court by this Receiver on the progress of the receivership since the Appointment (the "Quarterly Status Report") and the seventh report since the appointment of the Original Receiver (as defined below). The Quarterly Status Report is not an audit of financial condition and is intended solely to provide information for use by the Court in assessing the progress of the receivership.

Section XI of the Receivership Order also specifies that the Quarterly Status Report shall contain the following:

- A. A summary of the operations of the Receiver;
- B. The amount of cash on hand, the amount and nature of accrued administrative expenses, and the amount of unencumbered funds in the estate (attached as <u>Exhibit A</u> to the Quarterly Status Report);
- C. A schedule of all the Receiver's receipts and disbursements (attached as <u>Exhibit A</u> to the Quarterly Status Report), with one column for the quarterly period covered and a second column for the entire duration of the receivership;

- D. A description of all known Receivership Property, including approximate or actual valuations, anticipated or proposed dispositions, and reasons for retaining assets where no disposition is intended;
- E. A description of liquidated and unliquidated claims held by the Receivership Estate, including the need for forensic and/or investigatory resources; approximate valuations of claims; and anticipated or proposed methods of enforcing such claims (including likelihood of success in: (i) reducing the claims to judgment; and, (ii) collecting such judgments);
- F. A list of all known creditors with their addresses and the amounts of their claims; and
- G. The Receiver's recommendations for a continuation or discontinuation of the receivership and the reasons for the recommendations.

### **Summary of Operations**

During this period the Receiver has communicated with personnel from the offices of the Plaintiff, offices of counsel for certain Defendants, *pro se* Defendants, offices of the Original Receiver and his counsel, as well as insurance brokers, real estate brokers and professional appraisers in connection with issues regarding insurance coverage, avoidance claims, real property assets, personal property assets, and other assets. The Receiver has also responded to investor inquiries during the period.

The Receiver prepared and filed the *Report of Receiver's Activities from January 1*, 2022 through March 31, 2022 and Motion for Order Approving and Authorizing Payment of Receiver's and Professionals' Fees and Costs from January 1, 2022 through March 31, 2022 both of which were approved.

As noted in the Receiver's previous Quarterly Status Report, there was a motion pending on the District Court docket regarding settlement with Equiti UK entitled *Motion to Modify Asset*Freeze to Permit the Transfer of Funds, Including Certain Disputed Funds, from Equiti UK to the

Receiver (the "Equiti Motion") [ECF No. 295]. On May 18, 2022, an Order was entered granting the Equiti Motion [ECF No. 331]. The Receiver, his counsel and his accountants coordinated procedures for receipt of the Equiti funds. Equiti is currently taking the actions necessary to comply with applicable United Kingdom regulations to effectuate the transfer of the Equiti funds to the Receiver. It is anticipated that the Receiver will receive the funds by no later than August 5, 2022.

To provide investors and other interested parties with timely information regarding the status of the receivership, the Receiver and his team engaged a web designer in January 2022 to develop a receivership website. The website address is <a href="mailto:mediatrixreceivership.com">mediatrixreceivership.com</a>. One of the paraprofessionals of Receiver's counsel has been updating the website throughout the period to reflect significant activity in matters related to the receivership. This arrangement is significantly less expensive than paying a third-party to host the website.

## Cash on hand, the amount and nature of accrued administrative expenses, and the amount of unencumbered funds in the estate

As of June 30, 2022, the Receiver was holding \$12,394,266.87 net of accrued and unpaid fees and costs totaling \$139,946.28.

The breakdown for fees and costs are detailed on Exhibit A (p. 11), including accrued and unpaid fees and costs for the Receiver and his staff total \$4,235.00 in fees. Accrued and unpaid fees and costs for the Receiver's counsel total \$116,450.25 in fees plus \$96.91 in costs. Accrued and unpaid fees and costs for the Receiver's accountants, Rocky Mountain Advisory, LLC, total \$17,050.00 in fees plus \$111.24 in costs.

In addition there are accrued and unpaid fees and costs of from Robb Evans & Associates LLC and Barnes & Thornburg LLP for their assistance in supporting the transition from the

Original Receiver to the substitute Receiver. As also detailed on <u>Exhibit A</u> are accrued and unpaid fees and costs for Robb Evans & Associates LLC that total \$616.95 in fees plus \$0.53 in costs and for Barnes & Thornburg LLP that total \$1,375.40 in fees and \$10.00 in costs.

A motion for approval of fees and costs for this period of the receivership will be filed not later than September 13, 2022 in compliance with the Receiver Order.

### 1197 Lloyds Road Oak Point, TX

This property is a 1.0 acre lot improved with a good quality metal building with four rollup doors. There is no residence, water service, or operating septic tank system. The Receiver has been informed by the listing agent that the property is not eligible for water, sewer or septic service under existing zoning regulations in Denton County, Texas. Complicating the sale process, the property had been transferred from the owner, Bryant Sewall, to a family trust. In order to facilitate the sale of this property, the Receiver caused title to be placed back to Mr. Sewall. Following the revesting of title in Mr. Sewall's name, the Receiver's listing agent re-advertised the property for sale. The Receiver's listing agent has received a multiple offers with contracts at prices between \$188,000 and \$230,000. A Sale Motion was filed on July 19, 2022 [ECF 347]. Two updated appraisals and a brokers value opinion have been obtained.

### Lots in Port Charlotte, Florida

This property is 1.023 acres of raw land, consisting of four contiguous, tied lots zoned for multi-family use. Pursuant to the *Joint Motion to Preserve Real Property Commonly Known as 12088 Tetzel Avenue, Port Charlotte, Florida* filed by the SEC and Defendant Michael Young and Relief Defendant Maria Young [ECF No. 242] and the Court's Order [ECF No. 249] granting that motion and denying the Original Receiver's sale motion [ECF No. 227], no further action has been taken with respect to the lots in Port Charlotte, Florida.

Further, the Receiver also has continued with successful efforts to obtain replacement homeowners insurance for the Youngs' residence in Greenwood Village, Colorado as well as lots in Port Charlotte, Florida and 1197 Lloyds Road in Little Elm, Texas.

### Personal Property

The description of personal property was previously provided to the Court.

### **Liquidated and Unliquidated Claims**

During this period the Receiver sent three reminder tolling letters to charitable organizations. To date, we have received signed tolling agreements from eight charities and one alleged asset freeze violator. Follow up demand letters have been prepared for eight additional alleged asset freeze violators and, it is anticipated, will be mailed out by July 31, 2022. Further, the Receiver continues to identify and analyze data as well as perform legal research in support of potential avoidance actions, potential actions regarding certain vehicles and a 38' motor vessel, the "M/V Currenseas", and other personal property. During the period, the Receiver attempted to follow up on a demand letter to Michael Stewart for the titles of seven vehicles and also attempted to follow up with Mr. Stewart regarding an additional nine motor vehicle titles. Having exhausted informal efforts, the Receiver ultimately filed a motion for an order to show cause why Mr. Stewart should not be held in contempt on May 24, 2022, which motion was granted by Judge Crews on July 12, 2022. [ECF No. 346]. The Receiver also propounded discovery requests to Michael Stewart during the period. Although Mr. Stewart continues to remain radio silent, the Receiver has continually reached out (via email and phone) to meet and confer in good faith regarding the multiple outstanding issues involving Mr. Stewart—to no avail. Further, the Receiver received

certain financial records from a former financial Mediatrix employee. The Receiver also issued subpoenas and received records with information from third parties regarding assets.

On May 24, 2022, the Receiver filed his Motion for (1) Authority to Pursue Certain Avoidance Claims and Asset Freeze Violations; and (2) Approval of Proposed Settlement Procedures [ECF 332] (the "Avoidance Action Motion") along with a Forthwith Motion. Advocacy of the Avoidance Action Motion included drafting a filing a 12-page reply in support filed on June 6, 2022 [ECF 340] that successfully responded to the Young's opposition to the Action Motion. The Avoidance Action Motion was granted on June 9.

A 21-page Complaint with 12 pages of attachments was filed against 10 broker defendants on June 14, 2022. Summonses were issued on June 23, 2022. Domestic and international service upon the defendants is in process.

The Receiver's counsel also commenced work on additional avoidance action complaints within the period.

During the period Receiver's counsel has also drafted demand letters and tolling letters to other potential avoidance action defendants. Receiver's counsel have also worked with the Receiver's accountants to identify Net Winners.

### **Creditor List**

There is no new information regarding the creditor list since the Receiver's quarterly status report filed on January 28, 2022 [ECF No. 310].

Receiver's Recommendation as to Continuation of Receivership

The Receiver recommends continuation of the receivership to collect and liquidate the

remaining real and personal property assets as well as assess and prosecute certain claims of the

Receivership Estate. Some of those claims relate to transfers and payments made by the defendants

before and after the commencement of this case that may be subject to recovery.
