REPORT OF RECEIVER'S ACTIVITIES

July 1, 2022 through September 30, 2022

This report covers the activities of the Receiver¹ for the third quarterly period of 2022 ("<u>Q3</u> <u>2022</u>"). The Receiver was appointed on October 20, 2021 (the "<u>Appointment</u>") [ECF No. 284].

Section XI of the Order Appointing Receiver [ECF No. 153] (the "<u>Receiver Order</u>") directs the Receiver to file a report and accounting of the Receivership Estate on a quarterly basis. This is the fourth quarterly report to the Court by this Receiver on the progress of the receivership since the Appointment (the "<u>Quarterly Status Report</u>") and the ninth report since the appointment of the Original Receiver (as defined below). The Quarterly Status Report is not an audit of financial condition and is intended solely to provide information for use by the Court in assessing the progress of the receivership.

Section XI of the Receivership Order also specifies that the Quarterly Status Report shall contain the following:

- A. A summary of the operations of the Receiver;
- B. The amount of cash on hand, the amount and nature of accrued administrative expenses, and the amount of unencumbered funds in the estate (attached as <u>Exhibit A</u> to the Quarterly Status Report);
- C. A schedule of all the Receiver's receipts and disbursements (attached as <u>Exhibit A</u> to the Quarterly Status Report), with one column for the quarterly period covered and a second column for the entire duration of the receivership;

- D. A description of all known Receivership Property, including approximate or actual valuations, anticipated or proposed dispositions, and reasons for retaining assets where no disposition is intended;
- E. A description of liquidated and unliquidated claims held by the Receivership Estate, including the need for forensic and/or investigatory resources; approximate valuations of claims; and anticipated or proposed methods of enforcing such claims (including likelihood of success in: (i) reducing the claims to judgment; and, (ii) collecting such judgments);
- F. A list of all known creditors with their addresses and the amounts of their claims; and
- G. The Receiver's recommendations for a continuation or discontinuation of the receivership and the reasons for the recommendations.

Summary of Operations

During Q3 2022, the Receiver has communicated with personnel from the offices of the Plaintiff, offices of counsel for certain Defendants, *pro se* Defendants, offices of the Original Receiver² and his counsel, as well as insurance brokers, real estate brokers and professional appraisers in connection with issues regarding insurance coverage, avoidance claims, real property assets, personal property assets, and other assets. The Receiver has also responded to investor inquiries during the period.

The Receiver prepared and filed the *Report of Receiver's Activities from April 1, 2022 through June 30, 2022* and *Motion for Order Approving and Authorizing Payment of Receiver's and Professionals' Fees and Costs from April 1, 2022 through June 30, 2022* both of which were approved.

² The original Receiver Order appointed Brick Kane of Robb Evans & Associates LLC as Receiver (the "Original Receiver").

As noted in the Receiver's previous Quarterly Status Report [ECF No. 353], on May 18, 2022, an Order was entered [ECF No. 331] granting the SEC's *Motion to Modify Asset Freeze to Permit the Transfer of Funds, Including Certain Disputed Funds, from Equiti UK to the Receiver* (the "Equiti Motion") [ECF No. 295]. The Equiti Motion provided for the transfer of \$11,183,135.06 to the Receiver. The Receiver, his counsel and his accountants coordinated procedures for receipt of the Equiti funds, which were received on August 5, 2022 and placed in a segregated account. The Receiver's counsel also engaged in negotiations with Equiti regarding a subpoena issued for documents in Equiti's custody and ultimately received documents that may contain information regarding potentially recoverable assets.

To provide investors and other interested parties with timely information regarding the status of the receivership, the Receiver and his team engaged a web designer in January 2022 to develop a receivership website. The website address is <u>mediatrixreceivership.com</u>. One of the paraprofessionals of Receiver's counsel has been updating the website throughout the period to reflect significant activity in matters related to the receivership. This arrangement is significantly less expensive than paying a third-party to host the website.

Cash on hand, the amount and nature of accrued administrative expenses, and the amount of unencumbered funds in the estate

As of September 30, 2022, the Receiver was holding \$24,112,031.33 net of accrued and unpaid fees and costs totaling \$177,800.35.

The breakdown for fees and costs are detailed on <u>Exhibit A</u> (p. 13), including accrued and unpaid fees and costs for the Receiver and his staff total \$2,870.00 in fees. Accrued and unpaid fees and costs for the Receiver's counsel total \$153,668.05 in fees plus \$1,980.28 in costs. Accrued

and unpaid fees and costs for the Receiver's accountants, Rocky Mountain Advisory, LLC, total \$18,689.00 in fees plus \$226.92 in costs.

In addition there are accrued and unpaid fees from Robb Evans & Associates LLC and Barnes & Thornburg LLP for their assistance in supporting the transition from the Original Receiver to the substitute Receiver. Also as detailed on <u>Exhibit A</u> are accrued and unpaid fees for Robb Evans & Associates LLC that total \$126.90 and for Barnes & Thornburg LLP that total \$239.20.

A motion for approval of fees and costs of the receivership during Q3 2022 will be filed not later than December 14, 2022 in compliance with the Receiver Order.

1197 Lloyds Road Oak Point, TX

A motion seeking to sell the one (1) acre lot located at 1197 Lloyds Road, Oak Point, Texas for \$230,000 was filed on July 19, 2022 [ECF 347]. That motion was granted by Order entered on August 16, 2022 [ECF 354] ("<u>Sale Order</u>"). The Sale Order provided for an Overbid Auction, which the Receiver caused to be advertised in the Dallas Morning News in accordance with the Sale Order. The Receiver received two overbids, only one of which qualified at for the Overbid Auction. The Overbid Auction was held on September 12, 2022, which resulted in a final sale price in the amount of \$303,500.

Lots in Port Charlotte, Florida

This property is 1.023 acres of raw land, consisting of four contiguous, tied lots zoned for multi-family use. Pursuant to the *Joint Motion to Preserve Real Property Commonly Known as 12088 Tetzel Avenue, Port Charlotte, Florida* filed by the SEC and Defendant Michael Young and Relief Defendant Maria Young [ECF No. 242] and the Court's Order [ECF No. 249] granting that

motion and denying the Original Receiver's sale motion [ECF No. 227], no further action has been taken with respect to the lots in Port Charlotte, Florida.

Personal Property

The description of personal property was previously provided to the Court.

Liquidated and Unliquidated Claims

In late July, Receiver's counsel sent out 23 demand letters to certain Net Winners. As of the date of this report, Receiver's counsel has: negotiated, settled and received funds in connection with 14 Net Winners; is still negotiating with 1 Net Winner; has received no response from five Net Winners (who are all either international, or the 4-year statute of limitation has expired); and has determined that three Net Winners are no longer worth pursuing (one under criminal indictment and assets all frozen, one in bankruptcy, and one was determined to be a net loser). *See* Exhibit A for detail.

During Q3 2022 Receiver's counsel sent demand letters for eight additional alleged asset freeze violators.

Receiver's counsel also communicated with certain broker defendants to explore settlement. This process also included review and analysis of related documentation.

To date, the Receiver has negotiated and collected \$535,267.69 in avoidance settlements. *See* Exhibit A at 2.

Further, the Receiver continues to identify and analyze data as well as perform legal research in support of other potential avoidance actions, potential actions regarding certain vehicles and a 38' motor vessel, the "M/V Currenseas," and other personal property.

During the previous period, the Receiver attempted to follow up on a demand letter to Michael Stewart for the titles of seven vehicles and also attempted to follow up with Mr. Stewart regarding an additional nine motor vehicle titles. Mr. Stewart continues to remain radio silent and the Receiver continued to reach out (via email and phone) to meet and confer in good faith regarding the multiple outstanding issues involving Mr. Stewart—to no avail. Ultimately on October 10, 2022, the Receiver filed a Motion for Contempt [ECF 368] which also requested that the Court compel Mr. Stewart to respond to outstanding discovery requests. The Motion was granted on October 19, 2022 [ECF 372] (the "<u>Contempt Order</u>"). The Contempt Order has been stayed until November 1, 2022 [ECF No. 380]. The Receiver also issued a subpoena and received records with information from third parties regarding potential receivership assets as well as receiving responses to previously propounded subpoenas.

The Receiver's counsel also drafted follow-up demand letters and tolling letters to certain charitable entities. The Receiver is currently in negotiations with several of those entities to recover certain donations they received from Defendant Michael Young.

During Q3 2022, the Receiver's counsel also drafted demand letters and tolling letters to other potential avoidance action defendants, including certain Net Winners, *See* Liquidated and Unliquidated Claims section and attached <u>Exhibit A</u> for further detail

A 21-page Complaint with was filed against two charitable entities on August 31, 2022 (the "<u>Guardian Complaint</u>"). The charitable entities later demonstrated financial inability to pay, and the Guardian Complaint was voluntarily dismissed on October 18, 2022.

The Receiver's counsel also drafted demand letters to Defendant Michael Stewart, members of his family, related entities and former counsel to Mediatrix and Blue Isle demanding

repayment of transfers of receivership property they are alleged to have received and disposed of

in violation of the Asset Freeze Order.

Creditor List

Until the current period, there had been no new information regarding the creditor list since

the Original Receiver's initial quarterly status report filed on January 29, 2021 [ECF No. 215] (the

"Original Receiver's Initial Quarterly Report") which stated that:

The Plaintiff provided a list of investors to the [Original] Receiver, but the [Original] Receiver does not believe it is appropriate to disseminate a public list of the names and addresses of the investors, as unnecessarily invasive of their privacy rights and because it potentially exposes them to the risk of further harm as potential victims by other unscrupulous persons and entities who often prey on prior victims of financial fraud. In any event, the [Original] Receiver notes that the Order does not appear to empower the [Original] Receiver to propose claims allowance and distribution procedures for creditors, including the investors who may have been defrauded. At the appropriate time, the [Original] Receiver intends on discussing this issue with the Plaintiff and, if necessary, seeking instructions from the Court.

And further stated:

Attached at Exhibit B is a preliminary list of non-investor creditors. The [Original] Receiver is aware there are other creditors and is working to develop a more comprehensive list.

Exhibit B to the Original Receiver's Initial Quarterly Report listed the following four

creditors identified as of January 29, 2021:

The substitute Receiver has since received a communication on behalf of FX Strategy Master Fund (the "<u>Fund</u>") requesting that the Fund be added to the creditor list. However,

inclusion in the creditor list is not a determination that it is, in fact, a creditor, or the holder of an allowed claim because there has been no claims resolution procedure established.

Receiver's Recommendation as to Continuation of Receivership

The Receiver recommends continuation of the receivership to collect and liquidate the remaining real and personal property assets as well as assess and prosecute certain claims of the Receivership Estate. Some of those claims relate to transfers and payments made by the defendants before and after the commencement of this case that may be subject to recovery.
